YOUR Seguin View-Surveillance Camera Registry

The Seguin Police Department works in partnership with the citizens and businesses in our community to prevent and address criminal activity. Many properties in the city currently operate private surveillance systems. If a crime occurred nearby, they may not be aware their surveillance system captured information that could help solve the crime. Likewise, the police department may not be aware there are private surveillance systems in the area that could provide important information about the crime.

The Seguin Police Department is asking residents and businesses across the city to voluntarily register their privately owned surveillance systems so the police department will know where they can find surveillance cameras that may assist in their investigations. In the event that a crime occurs near their property, citizens who have registered through this program maybe contacted, notifying them about the crime and requesting access to their video footage for investigative purposes only. **Seguin Police Department will have no direct access to the surveillance systems.**
